Lunch Bunch Pricing for 2's and 3's Classes

This program is designed for children to eat lunch with friends and to participate in an enrichment program. The maximum number of days your child is eligible to stay is the number of days they are in school. The program runs for an additional 1½ hours after the regular class time: **11:30-1pm for 2 year old classes; 12-1:30pm for 3 year old classes.**

If you are enrolled in the 5-day 2's or 3's class and you are registering your child for 5 days of Lunch Bunch, you will receive a 20% discount!

Aftercare Pricing for 3's and Prek Classes

This program is designed for children to stay daily until 3:45pm. If the minimum enrollment for aftercare is not reached, aftercare will be cancelled.

General Information:

1. Your child must meet the age requirement by 9/1 of the class in which they are enrolled in (2, 3 or 4 years old).
2. If we have only one class of 2's and one class or 3's, priority will be given to children staying all 5 days first.
3. A \$150.00 non-refundable registration fee per child is due with the application form.
4. A deposit of 10% of the annual tuition for the upcoming school year is due with the school contract. This is non-refundable and must be paid by within 30 days from receipt of your acceptance letter.
5. The Maryland Immunization Certification, Health Inventory Form, and Emergency Card Form must be completed and on file.
6. **ALL CHILDREN MUST BE FULLY VACCINATED ACCORDING TO MSDE REQUIREMENTS** or have documentation from their physician detailing a medical need for a delayed vaccination schedule. Temple Beth Shalom Preschool does NOT accept religious exemptions for childhood vaccinations.
7. Monthly tuition payments must be set up on recurring payment plans beginning in August of each school year.
8. A child may not begin school without financial clearance (payment of the deposit and ACH/CC) and completion of all necessary forms.
9. Once accepted and you agree to enrollment in the program you are **agreeing to pay the full annual tuition cost and it is non-refundable and non-transferable, even if your child is withdrawn from the program for any reason.** See parent handbook for additional details on the financial obligations.
10. No fees for any classes will be pro-rated without approval from the Temple Administrator.
11. Delinquent payments may result in the child's enrollment being suspended.
12. All classes require a minimum enrollment. If enrollment is not met, you will be contacted.
13. Our preschool seeks to meet the needs of all children who attend our school, and as a general policy, each student will be evaluated, on an individual basis, to determine if Temple Beth Shalom is the right fit for your child. In the case of a child with special needs, consultation with the parents, other relevant professionals, and the Director must take place prior to class placement. Any reasonable modifications to our policies and practices to accommodate a child with special needs will be considered, as long as no fundamental alteration to our existing program or an existing cost to the program will incur. As with any matriculating student, all evaluations are determined on an individual basis, with our primary goal of meeting the needs of each student being paramount. We also have the right to unenroll any child if we cannot accommodate the needs of a child.
